## DO HEREBY CERTIFY:

FITT. That the name of this corporation shell bo: OCEANNIDE COMMUNITY ASSECTATION.

FECONO: That the specific and primary purpose for which this corporation is formed is to provide athletic, recreational end club facilities for the use of the residents of UCE:NIA; a planned community dayslopment, located in the City of Oceancids, County of San Diego, State of California, and their guests.

INIAD: That the general purpose and objects of this corporation are as fallows:

- (a) To leans, nurchase, hold, une and toke possession of and enjoy in fau nimple or otherwise may personal or real property nacessary for the uses and purposes of the corporation, and to sell, lease, dayd in trust, alien or dispose of the same at the pleasure of the corporation, and for the uses and purposes for which maid corporation is formed; and to buy and nell recl or personal property and to apply the proceeds of nois, including any and all income, to the uses and purposes of the corporation.
- (b) To pay all taxes and ossessments, if any, which may be liviad, by any public authority upon any property, owned or controlled by, or held in trust for the benefit of the corporation, or its members, on any ornemental factures, fixturas, tennia courta, playgrounds, swimming pools or club houses established therein or thereon, whether texes or assessed as a part thereof or separately.
- (c) To fix, sutablish or lavy, and collect from its members, dues, Feda, charges and essements, and to enforce any lies which may be provided to secure the payment thereof.
- (d) To borrow money, centreet debts, Issua bonds, notes and abbontures, and to encure the eame.
- (v) To do any end all other acts and things that a non-profit corporation is empowered to do, or that a netural person might do which may be necessary, conveniant or decireble in the englishmation of the offsire and for the full attainment of the general purposes of this corporation.

The foregoing statement of purposes shall be construed as a statement of both purposes and powers, and the purposes and powers stated in each clouse whell not. except where otherwice expressed, be construed as a limitation upon the general curposes for which this corporation is formed, but shell be regarded as independent purposes and powers.

Notwithstanding any contrary provision herein, no part of the activities of this corporation shall consist in exercise on procogenee or otherwise attempting to influence legislation, and the carrying on by this corporation at a profit of any business herningbous recited as a purpose of this corporation shall be marely incidental to end in furtherence of the general community betterment and recreational purposes for which this corporation is formed.

FCURTH: That this corporation is organized pursuant to the general Memoralit Corporation Law of the State of Culifornia. The corporation does not contemplate pacunitry gain or profit to the members thorsof, nor shall any net surnings, income. gain, profite or funds of this comporation in whatenever manner acquired by it ut any time inure or be distributed to or for the banefit of any private member,

director or other individual, but the same shall be devoted solely to the purposes for which the corporation is formed.  $\sim$ 

FIFTH: That the County in this State where the principal office for the transaction of the business of this corporation is to be located is the County of San Olugo.
