6. **Attendance:** The event must be attended by the homeowner or authorized tenant. A blanket invitation to the general public through flyers, flags, ads, etc. is prohibited. Inviting targeted audiences is permitted such as funeral attendees or members of an organization to which the sponsor has an affiliation.

7. Covenants:

- a. Homeowner and Homeowner's invitees, guests, and any person admitted to the Clubhouse by the Homeowner shall comply with all laws of the United States, the State of California, all ordinances of San Diego County and all rules and requirements of the local police and fire departments
- b. Homeowner and Homeowner's invitees, guests, and any person admitted to the Clubhouse by the Homeowner shall not injure nor damage the facilities in any manner, and shall not cause or permit anything to be done whereby such facilities shall be in any manner injured, marred or defaced.
- c. If the facilities, furnishing, equipment, or any portion of the project during the term of the Agreement shall be damaged by the act, default of negligence of Homeowner; Homeowner shall pay the Association upon demand any and all costs and fees to make repairs or replacements.
- d. Homeowner shall be responsible for any attorney's fees and costs incurred by the Association in enforcing any provisions of the agreement.
- e. The Association reserves the right to eject any person or person behaving in a disorderly manner or contrary to the rules and regulations of the Association and Clubhouse Rental Policies, and to prevent any damage to or destruction of the project during the period of the Homeowner's use.
- f. The Homeowner shall use the equipment and facilities in a proper and safe manner.
- g. The Homeowner shall not use the equipment and facilities if any health condition of the Homeowner makes such use dangerous or hazardous to the Homeowner or to any other person using the Clubhouse equipment and facilities.
